Instructions:

- The GenderBread person is a fun way to introduce kids to the concepts of identity, sex and self-expression.
- Provide kids with scissors and ask them to cut on the dotted lines on pag.6.
- Once they have the figures for identity and attraction, they can write on them who they are, what they like and who they like, and stick them on the Gender Bread person with tape, pins or blue tack following the scheme of pag.5.
- Finally, for self-expression, the kids can just colour and dress the Gender Bread person as they wish, using colours, materials, and drawing clothes, hair etc.

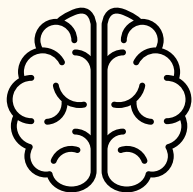

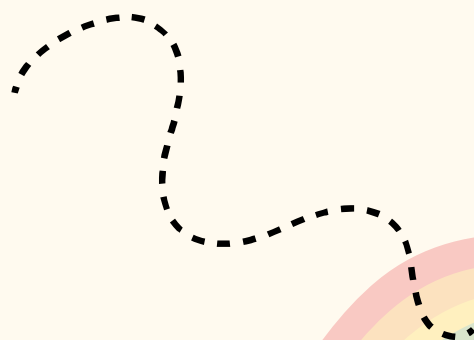
The identity is much more than gender: it is about what children like, what they dislike, what they dream of becoming etc.
